
# Informa's COMMITMENTS

At Informa Markets, our events run in accordance with the AllSecure Standard, with a commitment to ten key priorities:



## **BEFORE THE SHOW**



Visitors are encouraged to pre-register online.



Attendees should prepare enough Personal Protective Equipment (PPE) to use onsite.



Any participant with possible COVID-19 symptoms or feeling unwell, should not attend the show.



Exhibitors are required to provide a proof of COVID-19 Vaccination Record or COVID-19 Vaccination Medical Exemption Certificate (as applicable) which fulfills the requirements of "Vaccine Pass". For details, please refer to the latest government guidelines.

Exhibitor staff and Organiser are required to keep the proof for 31 days.

## AT THE ENTRANCES



Compulsory for all participants to wear face masks (recommended to wear surgical mask) at all times in the venue. No admittance is allowed without a face mask.

Automatic hand sanitizer dispenser stands are available.



Face masks can be purchased onsite.



Event signage with preventive measures and symptoms of COVID-19 will be prominently displayed in the common areas.

### **Temperature Screening**

- It is mandatory for all attendees to undergo thermal screening before
- entering the venue. • Additional temperature checks may be carried out inside the venue, before entry to the exhibition halls.

Hong Kong Quarantine Order Anyone subject to the quarantine order will be denied entry to the venue.





## **Trace and Contact**

- Admission is controlled, granted only for exhibitors and invited buyers with valid identity document, ensuring traceability of all participants, subject to the Hong Kong privacy ordinance.
- On-site identity verification will be conducted to confirm the identity of all attendees.

### Vaccine Pass & LeaveHomeSafe

• Visitors are required to a) scan the "LeaveHomeSafe" QR code and display it to the entrance staff and b) proactively present the COVID-19 Vaccination Record or COVID-19 Vaccination Medical Exemption Certificate (as applicable) which fulfills the requirements of "Vaccine Pass" at the show venue and each catering outlet.

\*Data saved in the QR Code Vertification Scanner is enrypted and personal data will become non-identifiable after processing. Saved personal data will be erased automatically after 31 days.

## REGISTRATION

## INSIDE THE VENUE AND STANDS



Exhibitors are requested to manage capacity inside the stands according to government guidelines.








Venue main entrance floor mats are sprayed with diluted bleach.







Doors, door handles at major entrances, escalator handrails are protected by photocatalyst for its physical puncture sterilization.

Venue will be disinfected at the end of the day after general cleaning.



Exhibition venue ventilation system, supplying fresh air, is running at maximum capacity.

Specific rubbish bins for disposal of

used face masks are provided at prominent areas.

### CATERING



No eating/drinking inside stands. Designated catering area will be arranged.



All outlets support cashless payment system.



Tables and chairs in restaurants will be cleaned by diluted bleach.



Water Fountains / Dispensers

Only pre-packed / individually packed food is available at designated catering area.



facilities are now suspended.



Tables will be set at a distance based on the government guidelines.













### Hand Washing / Sanitising

Hand sanitising stations are located throughout the event. We encourage all participants to regularly wash and disinfect their hands.

### **Venue Hygiene**

Additional hand sanitisers at the entrances, lift lobbies, customer / information counters, restaurants.

### SPECIAL ACTIONS




**First Aid Team** First aid support will be available onsite during the entire event.

**Isolation Rooms** Any participant with possible COVID-19 symptoms (particularly fever) will be held in a separate quarantine area; the Organiser will work with the local medical authority to ensure proper protocols and support are followed.





Disinfectant spray, wipes and etc can be purchased from official stand contractors onsite.





Masks may be purchased at convenience store and vending machines on-site.



If an individual who has contracted COVID-19 is found to have visited the exhibition, or if exhibitors or other show personnel have been confirmed to have contracted COVID-19, the Organiser will immediately contact the related authorities and take appropriate preventive measures according to their guidelines.

## CONFERENCES/SEMINARS/SPECIAL EVENTS

## PLEASE REMEMBER



Handshaking Following the guidance of global and local authorities, eliminating handshakes is highly recommended.



Download e-brochure/ e-news through QR code, rather than print promotional material.



Utilise E-Payment i.e. Octopus card, QR code, online banking, WeChat pay, Apple & Google Pay, rather than cash onsite.



Throughout the event, announcements will be broadcast repeatedly to remind the importance of maintaining physical distance, washing and sanitising hands.
